RD Loan Limit Announced

Truist Bank (Truist) is pleased to announce an increase to the 2021 maximum loan limit for Rural Development (RD) transactions.

Effective Dates

Revised loan limits are available for new locks on or after January 4, 2021.

Background Information

Federal Housing Finance Agency (FHFA) increased to the conforming loan limit to \$548,250. Truist aligns the maximum eligible loan amount, for RD transactions, to the FHFA conforming loan limit.

For RD transactions, \$548,250 is the 2021 maximum loan limit.
