### USDA Retraction of Non-U.S. Citizen Eligibility Standards Updates

Truist Bank (Truist) announces alignment with USDA's recently issued retraction of Non-U.S. Citizen Eligibility.

#### **Effective Dates**

Effective for new and existing RD loan applications with a conditional commitment issued on or after March 18, 2025

### **Background Information**

On March 18, 2025, the Single-Family Housing Guaranteed Loan Program (SFHGLP) announced the immediate termination of the temporary authority originally communicated on April 29, 2022. The authority allowed some non-U.S. Citizens to be eligible to apply for a guaranteed loan.

#### **Bulletin Details**

As of March 18, 2025, the temporary authority is no longer valid. The borrower must be a U.S. citizen, a U.S. non-citizen national, or a "qualified alien". Loan files with a non-permanent resident alien must meet USDA's qualified alien status as well as Truist's requirements within Section 1.24 – Non-Permanent Resident Alien Requirements Standard.

Truist reference materials have been updated with this publication and include:

- Revising EAD categories to align with USDA Qualified Alien Status allowing only A-3, A-4, A-5 and A-10.
- Removing all references to visa classifications no longer allowed by USDA.
